- A copy of your Food Manufacturing Permit (if needed).
- A copy of your menu with pricing.
- Vendors are responsible for leaving your area clean and free of trash.
- Fees due for the booth you need. (Notice there has been some changes).
- The refundable deposit for your booth.
- This application completed.

Booth Fees

Buildings (see map)

- B1 & B2 are \$1100.00 which does include electricity and temporary health permit
- B3 thru B13 are \$500.00 which does include electricity and temporary health permit
- B14 & B15 are \$900.00 which does include electricity and temporary health permit
- Grounds booths (G1 thru G41) are 10'x10' and are \$450.00 which does include electricity and temporary health permit. For ground booths you will need extension cords and they are on dirt flooring.
- All booths please add \$100.00 refundable deposit to your total.

All applications must be submitted to KCFA before August 15th. After August 1st KCFA will only accept money orders or cashiers checks.

There will be a refundable deposit for all booths of \$100. In order to receive your deposit back you must follow all rules.

For last years vendors wishing to return, we will need your application and deposit before April 30th to ensure your booth space. After April 30th we will place you in any

space available. The total due for your booth is due before July 15th, after that your booth may not be available to you.

Rules:

These rules will be enforced strictly. If they are not followed you will not be invited back again to the Kendall County Fair.

- Vendors are responsible for leaving your area clean and free of trash.
- Vendors are not allowed to sell water, sodas, or alcohol.
- Vendors must stay open the entire time designated for your area unless arrangements are made with the director in charge in advance to the fair. Times are Friday from 5pm to 12am, Saturday from 11am to 12am, and Sunday from 11am to 12am. **Break down and clean up will be Monday from 8am to 12pm.**
- Vendors must accept coupons for food and drinks; Monday morning we will reimburse you 100% of face value.
- Vendors must respect their neighboring vendors.
